BOARDING RATES

B.

- 1. In exchange for boarding services to be provided by The Cat Cottage the owner agrees to pay to The Cat Cottage
 - a. The current rates of the Cat Cottage, as listed at catcottage.ca

the following policies and agree to the terms and conditions set out below:

b. For the purposes of billing, the day begins at the time that the cat is delivered to the premises and ends at 12:00 o'clock noon the following day. If the cat is retrieved by the Owner after 12:00 o'clock noon, then a new day has commenced and will be billed to the Owner as such.

The Cat Cottage enforces the following policies and the Owner confirms that he/she/they have reviewed

RESERVATIONS

2. A non-refundable deposit of \$100.00 is required for all reservations during the month of December.

DELIVERY OF THE CAT

- 3. The Owner agrees:
 - a. To deliver the cat to The Cat Cottage in a secure carrying case and to leave this case on the premises;
 - b. That by delivering the cat to the The Cat Cottage premises, the Owner acknowledges that the premises and accommodations for the cat have been inspected and found to be in a clean and sanitary condition. The Owner is satisfied as to the safety of the facility, the condition of the premises in which the cat will be housed and all other arrangements under which the cat will be kept.

CONDITION OF THE CAT

- 4. The Owner ensures that the particulars concerning each cat are correct and true and that to the best of his/her knowledge:
 - a. The cat has been immunized within the past 12 months, or has written consent from their Veterinarian to exempt the cat from immunizations and to release The Cat Cottage from responsibility for any illness that may have been prevented by immunizations;
 - b. The cat is free of fleas;
 - c. The cat does not have any medical condition or disease which adversely affects the health of the cat that has not been completely described in the Boarding Agreement;
 - d. The cat does not have any disease or illness which may be contagious to other cats.
- 5. The Owner acknowledges that any incorrect information provided by the Owner to The Cat Cottage may cause The Cat Cottage to be liable to third party Owners for damages or injury to their respective cats while in the possession of The Cat Cottage and the Owner agrees to indemnify and hold harmless The Cat Cottage for all such claims.

EMERGENCY MEDICAL ATTENTION

- 6. The Owner agrees that The Cat Cottage has the sole discretion as to whether the cat requires emergency medical care from a veterinarian.
- 7. If The Cat Cottage determines that the cat requires emergency medical attention, The Cat Cottage may consult with and/or deliver the cat to the veterinarian patronized by the Owner as stated in the Boarding Agreement, at the Owner's expense, provided that it is within business hours and that the office is within a reasonable distance of The Cat Cottage.
- 8. If the Owner's veterinarian is unavailable, The Cat Cottage, in its sole discretion, may consult with and deliver the cat to another qualified veterinarian, at the Owner's expense.

- 9. All charges related to the emergency medical treatment of the cat (including mileage at \$0.50 per mile and wages paid to the employee of The Cat Cottage at the rate of \$20.00 per hour for the time spent for traveling and attendance upon the veterinarian) are to the account of the Owner;
- 10. Where possible, in the event of a medical emergency with respect to the cat, The Cat Cottage will make all reasonable efforts to contact the Owner and/or the Owner's emergency contact, as provided in the Boarding Agreement. If we are successful in contacting the Owner, or the Owner's emergency contact, he/she will then be able to make decisions on how to proceed with care. If we are unable to contact the Owner, or the Owner's emergency contact, then The Cat Cottage will make medical decisions based on the advice of the veterinarian, not to exceed the maximum cost specified by the Owner in this Boarding Agreement.
- 11. Any veterinary expenses paid by The Cat Cottage or its employees, on behalf of the Owner shall be reimbursed to The Cat Cottage as soon as possible and prior to the return of the cat to the Owner.

RELEASE, WAIVER AND INDEMNITY
